It is hereby notified to all concerned that for filling up the vacant seats under State/Management Quota (category-wise) in Private un-aided Dental Colleges of the State of Himachal Pradesh after exhausting the merit list as notified on **25.6.2018 by the H.P. University**, the applications from the interested eligible candidates are invited on the prescribed application form as uploaded on the University website www.hpuniv.nic.in alongwith photocopies of relevant documents as mentioned in the counselling prospectus issued by the H.P. University uploaded on the University website who qualified the NEET-UG-2018 which must be submitted by the candidates by hand in the office of the Assistant Registrar(Entrance Tests) H.P. University, Shimla -5 on 26.8.2018 up to 2:00 PM beyond which no application shall be entertained. The applications should be accompanied with counselling fee of Rs. 1800/- for General & other categories and for Rs. 900/- for SC/ST /IRDP/BPL/PH categories in the shape of bank draft to be drawn in favour of the Finance Officer, H.P. University, Shimla. The vacant/unfilled BDS seats (State quota /Management Quota) will be filled-up through Centralized Counseling Committee during the MOP-up Round of Counseling to be held on **27.8.2018 at 3:00 PM in H.P. University Auditorium, Shimla** with the condition that the interested candidates for seeking admission to BDS course under State/Management Quota against vacant seats in private Dental Colleges, candidates are required to deposit the 50% amount of tuition fee in cash before allotment of seats and remaining amount of fee alongwith other dues shall be deposited in the colleges concerned on 29.8.2018 .
