NOTICE FOR 2nd MOP-UP ROUND OF COUNSELLING FOR FILLING VACANT SEATS OF BDS UNDER STATE/MANAGEMENT QUOTA IN GOVT./PRIVATE DENTRAL COLLEGES FOR THE ACADEMIC SESSION-2018-19

Pursuant to the directions conveyed by the Director Medical Education & Research, H.P. vide e.mail letter No.HFW(DME)H(III)G-301/10-Vol-IX dated 7th September, 2018, the 2nd Mop-up Round of Counselling for filling up BDS vacant seats under State/Management Quota in the H.P. Govt. Dental College, Shimla and the private Dental Colleges situated in the State of Himachal Pradesh shall be conducted **on 12.09.2018 at 4 PM in the H.P. University Auditorium, Summer Hill, Shimla-5**. All the interested wait listed candidates who attended the Mop-up round of counselling held 5.09.2018 and including those admitted candidates of private dental colleges who are eligible for shifting by way of up-gradation in order of merit under State Quota seats in the H.P. Govt. Dental College, Shimla and one private dental college to another only for up-gradation, may report for 2nd mop-up round of counselling for admission to BDS course alongwith 50% tuition fee in cash as per provision as contained under Clause-VIII.7(b) at page-31 of the prospectus on the above mentioned date, time & venue. It may noted that the candidates reporting without requisite fee in the counselling shall not be allotted any seat. **It may noted that no shifting in the same quota seat shall be allowed from one private dental college to another .**

The list of candidates to be called for the aforesaid counselling shall be uploaded on the University website www.hpuniv.nic.in on **10.09.2018 (AN)**. Therefore, the candidates are advised to make themselves present in the counselling. In case of unavoidable reasons, the candidate can depute his/her authorised representative with a letter of authority to attend the aforesaid counselling, failing which his/her claim for admission shall be forfeited. Candidates those not admitted in any of the college must bring with them all original certificates on the day of counselling.

Besides this, the fresh applications from the interested eligible and qualified candidates of NEET-UG-2018 are hereby invited on the prescribed application form (uploaded on the University website www.hpuniv.nic.in) for filling up BDS vacant seats under Management Quota in the Private Dental Colleges by e.mail: arentrancetests919@gmail.com with NEET-UG-2018 result cards by **11.09.2018 upto 4PM**. The aforesaid candidates shall also attend the 2nd Mop-up round of counselling on the above mentioned date, time and venue alongwith original application form and Bank Draft of counselling fee of Rs.1800/- for General & Ors. categories and Rs.900/- for SC/ST/IRDP/BPL/PH categories to be drawn in favour of the Finance Officer, H.P. University, Shimla and photocopies duly self-attested of all required certificates. All original certificates are also required on the day of counselling. However, the vacant seat, if any under State Quota in the private dental colleges shall also be filled up on the aforesaid counselling after exhausting the waiting list of Mop-up round of counselling. They may be noted that their merit list shall be drawn separately, which shall be operated only after exhausting the waiting list of Mop-up round of counselling for filling up vacant seats under State/Management Quota in private dental colleges. The candidates are also required to bring with them amount of 50% tuition fee in cash as per provision contained under Clause-VIII.7(b) at page-31 of the prospectus on the day of counselling. It may noted that the candidates reporting without requisite fee in the counselling shall not be allotted any seat
