Subject: Regarding admission to BDS course for the academic session 2018-19.

Sir/Madam,

In pursuance to the Mop-up round of counselling held on 05.09.2018 in the H.P. University Auditorium, Summer Hill, Shimla-5, I am directed to send herewith a list of candidates sponsored college-wise as well as category-wise (**Annexure-A**) from the waiting list and the 2nd merit list or by way of shifting from one college to another by the Centralized Counselling Committee headed by the Director Medical Education & Research, H.P. Shimla in order of merit-cum-choice of the colleges as per merit drawn by the University on the basis of NEET-UG-2018 for provisional admissions to BDS course for the academic session 2018-19 in the respective Govt./Private Dental Colleges against the vacant seats under State/Management Quota seats as conveyed by the Principals of the colleges concerned. The allotment of seats to the candidates under reference have been made after deposition of 50% amount of tuition fee with the representatives of the colleges concerned during the counselling as per provision VIII.7(b) of the prospectus. However, the recommendations of the candidates for admission to the aforesaid courses is provisional and subject to removal of discrepancy(ies), if any, as pointed out at the time of counselling by the Counselling Committee which have been marked on the admission forms as well as intimated to the candidates concerned on their admission letters. The admission is further subject to final verification of eligibility criteria and medical fitness as well as completion of all pre-admission requirements as per provisions of the prospectus.

2. The candidates as recommended for admissions to BDS course have been informed in writing by issuing provisional admission letters, which have been uploaded on the University website www.hpuniv.nic.in with a copy endorsed to you to report to their respective dental colleges for completing the all pre-admission requirement as per provisions of the prospectus along with remittance of fee **on 10.09.2018 at 10 AM**, failing which their claim for admission shall stand forfeited/cancelled.

3. The original admission forms with relevant documents of each candidates as sponsored afresh from the waiting list for admission under letter reference have already been handed over to the representatives of the colleges concerned along with list of the candidates for your ready reference and record. However, the candidates who have been shifted from one college to another as per Annexure-A, their original Admission forms with relevant documents are required to be sent by the Principals of the concerned colleges to the Principals of new allotted colleges through speed-Post in order to reach the same within the admission process under intimation to the University, but their counselling forms in original have already been sent to you.

4. The candidates who do not report for admission on the due date as mentioned above, necessary intimation to this effect along with category-wise list of the candidates so admitted and their admission forms may kindly be sent to this office through Fax/Speed-Post on or before 11.09.2018 in order to fill up the vacant seats in the 2nd Mop-Up round of counselling .

5. It may kindly be ensured that before admitting the candidates, the final eligibility of each candidate must be checked/ verified strictly as per the provisions IV.(A) 1 to 4 at pages 17 -20 of the prospectus and the discrepancy so pointed out by the counselling committee during the course of counselling should have also been got settled. The H.P. bonafide/domicile and other reserved categories certificate(s) including character certificates as well as attested photo-copies of relevant documents wherever required as per provisions of the prospectus may also be obtained from the concerned candidates. The photograph & signatures of the above candidates may kindly be verified/matched with the images of photographs, signatures of NEET-UG-2018 as per CD sent to you.

6. The candidates who have passed their 10+2 examination other than HP Board of School Education, Dharamshala/CBSE/ICSE, the equivalence certificate to this effect may be obtained from such candidates.
