Applications are invited for admission in the Boys & Girls hostels from the candidates admitted in M.A./M.Sc./LL.B/MBA/MTA/MCA/M.Ed./B.Ed. (I/III/V semester) and Ph.D. course, for the session 2017-18. The candidates are hereby directed to apply through Chairperson of the department on the prescribed hostel admission form (in duplicate) to be downloaded from the University website www.hpuniv.nic.in.

The hostel admission form complete in all respects with two latest passport size photographs duly affixed and attested by the Chairperson, accompanied with a domicile certificate and aadhar card must reach the Chief Warden Office by **21st July, 2017 positively**. Incomplete forms and the forms received without required documents will be rejected. All the formalities are required to be completed by the candidate concerned himself/herself.

The eligible candidate(s) shall be allotted hostel subject to the availability of seats on the basis of merit and number of vacancies available for the department as worked out proportionately among the departments. The allotment of seats will be made by the Wardens' Committee as per the approved scheme of allotment. However, no allotment will be made to the candidates against whom an FIR is lodged by the University.

The students shall be required to deposit their hostels dues in the office of the Chief Warden after depositing the mess security in the allotted hostel. The allotment of seats in the hostel shall stand automatically cancelled in case the candidate fails to deposit his/her mess security and hostel dues within the stipulated period and the vacancy shall be allotted to the candidates next in the order of merit.

(While applying for admissions to the hostels the candidates must consult Handbook of Information (2017-18) as available on the website of the University for eligibility conditions.)

Note : On account of hostel Identity Card an amount of ` 20/- will be charged extra to the boarders at the time of hostel admission fee.
